**ORDER CONCERNING DEADLINES  
FOR DISSEMINATING CLASS  
NOTICE AND SETTING A HEARING  
FOR FINAL APPROVAL OF  
SETTLEMENTS**

This matter is before the Court on the parties' Stipulation Concerning Proposed Deadlines for Disseminating Class Notice and Setting a Hearing for Final Approval of Settlements. The Court, having considered the stipulation, HEREBY ORDERS that:

1. The following schedule shall apply regarding the dissemination of class notice and final approval of the settlements reached in this case to date:

1	Deadline for Plaintiffs to file motion to disseminate class notice as to all settlements	April 5, 2022

3	Deadline for any opposition to Plaintiffs' motion to disseminate class notice as to all settlements	April 15, 2022
4		
5	Deadline for reply brief in support of Plaintiffs' motion to disseminate class notice as to all settlements	April 18, 2022
6		
7	Hearing date on Plaintiffs' motion to disseminate class notice as to all settlements	April 22, 2022
8		
9	Deadline for all Defendants to provide class list information to settlement administrator	April 29, 2022
10		
11	Deadline for CRST Defendants to provide evidence of costs incurred to provide class list information	May 3, 2022
12		
13	Deadline to disseminate class notice	May 10, 2022

15	Deadline for settlement administrator to reimburse CRST Defendants and C.R. England for costs of providing class list information pursuant to Court's February 24, 2022 order (Dkt. No. 562)	May 27, 2022

17	Deadline to opt out of, or file objections to, settlements	June 24, 2022

19	Deadline for Plaintiffs to file: (1) motion for final approval of settlements; and (2) motion for attorneys' fees, costs, administrative fees, and service awards	July 1, 2022

21	Deadline for any briefs in opposition to: (1) Plaintiffs' motion for final approval of settlements; and (2) Plaintiffs' motion for attorneys' fees, costs, administrative fees, and service awards	July 8, 2022

1           2.     If Plaintiffs' forthcoming motion to disseminate class notice is unopposed,  
2 Plaintiffs may notice the motion for an April 15, 2022 hearing date.

3           3.     All Defendants shall provide the following information for members of the  
4 Settlement Class: (a) full name; (b) driver ID (or similar designation as used by each  
5 Defendant); (c) Social Security number; (d) last known address(es); (e) last known phone  
6 number(s); (f) last known email address(es); (g) date(s) of hire; and (h) date(s) of  
7 termination of employment to the settlement administrator to effectuate notice to the  
8 Settlement Class.

9           4.     For purposes of complying with Paragraph 3, C.R. England shall provide the  
10 information specified in Paragraph 3 for all commercial motor vehicle drivers that entered  
11 into an agreement with C.R. England, Inc. in which the driver agreed to work for C.R.  
12 England, Inc. for a specified period of time in return for training provided by, funded by,  
13 or reimbursed by C.R. England, and who was employed by C.R. England under that  
14 agreement at any time from May 15, 2013 through the date of the Court's preliminary  
15 approval of the settlement between Plaintiffs and Stevens.

16           5.     If the Court has not issued a decision regarding Plaintiffs' motion for  
17 preliminary approval of the settlement reached with Stevens Transport by April 5, 2022,  
18 then Plaintiffs' motion to disseminate class notice shall include alternative forms of class  
19 notice with one form including the Stevens Transport settlement and one form without it.
